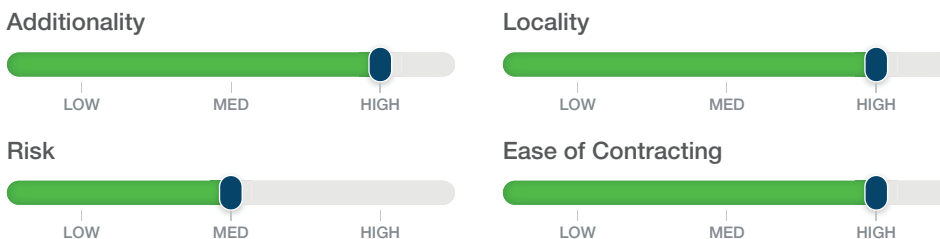

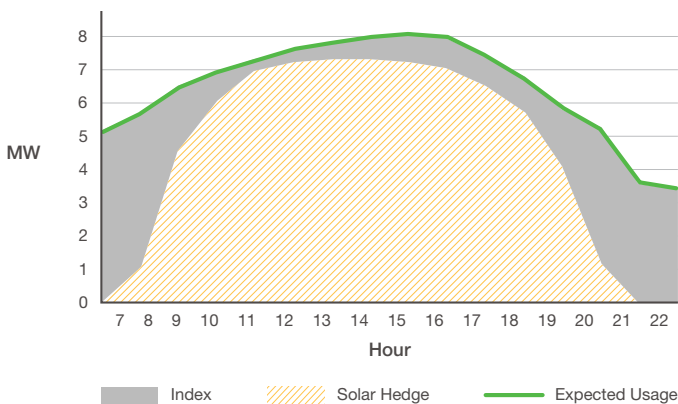

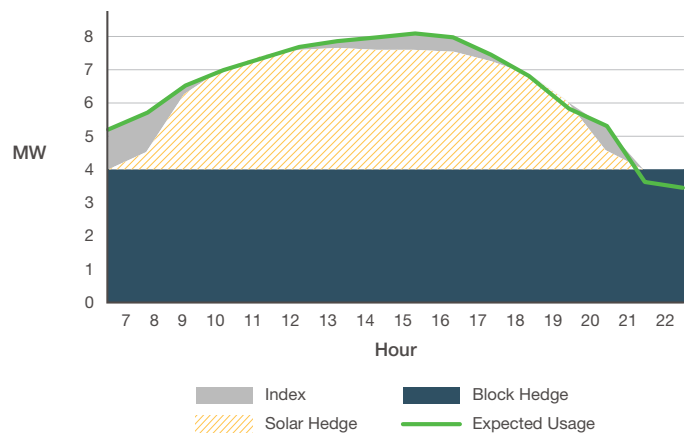
Solar shape + Index

- Solar-shaped power is purchased with remaining power purchased at market index rate
- Solar shape must be purchased for entire term with set price



Block + Solar shape + Index

- Block of power is purchased for the length of the contract term followed by a solar-shaped hedge
- Remaining usage purchased at market index rate
- Solar shape must be purchased for entire term with set price



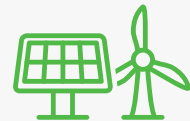
